Preference will be given to church and ecumenical programs with Presbyterian participation. A report of activities and participation must be submitted to be eligible for a grant next year. Any unused funds must be returned to the Presbytery of Giddings-Lovejoy.

Applications must be approved by the church Session or the organization's board of directors.
